**PROCEEDINGS DATED 30<sup>TH</sup> JUNE, 2023**  
**BASKETBALL FEDERATION OF INDIA**  
**(ELECTION 2023)**

1. As per the calendar of events/notification/proceedings dated 11.06.2023, today is the last date of withdrawal of the candidates, scrutiny of nomination papers and publication of list of valid nomination papers of all the associations.
2. It is 2.35 PM.
3. Sh. Sasidharan C, who had filed his nomination for the post of Vice President, has appeared in person and submitted the notice of withdrawal of his candidature from the post of Vice President. It is in Form 5. It has been duly filled in and signed by him. Accordingly, it is taken on record and shall be reflected in the further proceedings.
4. Sh. Kulvinder Singh Gill has also appeared with Sh. Sasidharan C and has pointed out that in the proceedings dated 29.06.2023, there appears to be some typographical error on the first page. He has pointed out that underneath the name of Mr. Aadhav Arjuna, \*\* shows his serial number in the electoral roll as "41". It should have been 19. The original list of nominated candidates published in Form 3 on 29.06.2023 contains the above error only on page 1. Otherwise, the correct serial number of Aadhav Arjuna is mentioned on page nos. 7 and 9. Therefore, it is mentioned for keeping the record straight that the serial number



in the Electoral College List used by the previous Returning Officer of Mr. Aadhav Arjuna is concerned was 19. However, so far as the serial number of Mr. Aadhav Arjuna in the Electoral List supplied to the undersigned by the office of learned Administrator, is 21 and has been correctly mentioned on all pages against the name of Mr. Aadhav Arjuna. The election, if found necessary after security of the nomination forms, shall be on the basis of electoral list copy of which had been supplied to the undersigned by the office of the learned Administrator and which had been earlier uploaded on the website.

5. As per the Constitution of the Basketball Federation of India (as amended upto date), there shall be 7 (seven) Vice Presidents (including one lady Vice President). Only Ms. Seema Sharma has filed her nomination for the post of Vice President.
6. As already mentioned, the nomination papers which had been received earlier by the previous Returning Officer are also being taken into account while scrutinizing the nomination forms. The earlier Returning Officer had rejected a few nomination forms. The same are now to be taken as valid nomination forms in view of the order dated 02.05.2023 passed by the Hon'ble Delhi High Court.
7. After passing of the orders dated 02.05.2023 and 08.05.2023, only three nominations forms had been received till 27.06.2023, which was the last date of receiving the nomination forms. Out of those 3 (three) nomination forms, one candidate Mr.



Sashidharan C has today filed his notice of withdrawal of candidature in Form 5.

8. The nomination forms received have been scrutinized.
9. As already mentioned in the list of nominated candidates published on 29.06.2023, Mr. Ajeet Singh Rathore had withdrawn his nomination on 12.02.2023 for the post of Vice President. Mr. Sumesh Chadha had withdrawn his nomination on 12.02.2023 for the post of Joint Secretary. Mr. Ajeet Singh Rathore had also withdrawn his nomination on 12.02.2023 for the post of Treasurer.
10. As mentioned earlier the election for 1 (One) post for **President**; 7 (Seven) post for **Vice President** (which includes one lady Vice President); 1 (One) post of **Secretary General**; 5 (Five) posts of **Joint Secretary**; 1 (One) post of **Treasurer** and 11 (Eleven) posts of **Member Executive Board** are to be held.






