- 1. Travelling as per norms.
- 2. Sports Kit to be provided as per norms once in a year.
- 3. List of Core probable and Officials and supporting staff reported for the Camp should be forwarded to the TEAMS Division immediately after 2nd day from the commencement date of the Camp as per sanction.
- 4. Any inclusion / deletion of National Campers should not be entertained without prior approval of the TEAMS Division.
- On conclusion of Coaching Camp, Camp In charge shall submit a report of Coaching Camp through the Regional Director, SAI, Bangalore within 10 days to Teams Division.
- 6. The Camp has been sanctioned to Basketball Federation of India and BFI will make all necessary arrangements with regards to FOP, Lodging, Boarding etc., and the Regional Director, SAI Bangalore will settle the account as per Camp norms.
- 7. It is mandatory for the Regional Heads/ Centre heads and the concerned Federation to submit the monthly expenditure statement on the last working day of the month and Utilization Certificate within 15 days after completion of the Camp to the Finance.
- 8. The monitoring of attendance on daily basis shall be maintained.
- 9. Issued Equipment to be verified & entered into stock register.
- 10. The list of the players who will attend the camp is placed overleaf.
